CHILDREN POLICY

Breakfast is free of charge for children under 6 years old.

Children from 6 to 11 years old may share the parents bed and pay only :

- From 01 Jan 2016 to 30 Apr 2016 : 125'000 đ
- From 01 May 2016 to 30 Oct 2016 : 150'000 đ

Children from 12 to 15 years old require an extra bed ; any child in an extra bed pays :

- From 01 Jan 2016 to 30 Apr 2016 : 1'050'000 đ
- From 01 May 2016 to 30 Oct 2016 : 1'125'000 đ

Maximum occupancy per room is 2 adults, 1 child under 12 years old sharing its parents' bed, and 1 child under 16 years old with an extra bed.

RESERVATION PROCEDURE

All reservation requests must be official and legible, and submitted to the Lodge's management. Reservations are subject to availability. The reservations can be made by facsimile or e-mail to the numbers stipulated below :

A rooming list must be submitted to the lodge's management together with any details, meal requirements and special arrangements requests upon reservation.

A reservation is considered guaranteed once it has been confirmed in writing by the Lodge, and the availability will be held until the guests' arrival, provided that the payment terms are respected, lest the reservation be considered cancelled on the part of the Client and penalties may apply.

CANCELLATION

Cancellation is valid once approved by the Lodge's management.

- up to 21 calendar days before check-in date : no charge
- from 20 to 14 calendar days before check-in date : 10% of the full value of the scheduled stay
- from 13 to 07 calendar days before check-in date : 30% of the full value of the scheduled stay
- from 06 to 03 calendar days before check-in date : 70% of the full value of the scheduled stay
- from 02 days to check-in date and no show : 100% of the full value of the scheduled stay

Any amendment to the reservation after 21 calendar days before scheduled check-in date may give rise to cancellation fees.

PAYMENT TERMS

All payments under this agreement should be made in VND or USD.

Check-in :

- Check-in time is from 14:00

- Early check-in from 8:00 AM to 12:00 PM is subject to approval and subject to charge.
- Very early check-in, before 8:00 AM, is subject to approval by the Lodge's management and charged 100% of the room rate.

Check-out :

- Check-out time before 12:00 PM
- Check-out after 12:00 PM is subject to approval by the Lodge's management.
- Late check-out, from 14:00 to 18:00, is subject to approval and subject to charge.
- Very late check-out, after 18:00, is subject to approval by the Lodge's management and charged 100% of the room rate.

The Lodge does not offer an insurance other than its own public liability cover. The Client advises the Guests to take a personal insurance to cover all activities taking place at and about the Lodge.
